The dwellings are part of the State Government's East Kimberly Transitional Housing Program, which provides housing and a range of wraparound supports to Aboriginal people who aspire to own their own home or live in a private rental.

There are a total of 16 new social housing homes spread across the East Kimberly, including the two MGCBM is building.

## TARGET 120 PROGRAM UPDATE

**MG Corporation continued its successful delivery of the Target 120 program in the quarter on behalf of the State Government.**

The Target 120 team at MG Corporation provides daily support to the participants and families, along with monthly 'Back to Country' trips for the whole family, and fortnightly activities with the participants on country and with support from MG elders.

MG Corporation had 11 active clients and worked with 40 additional family members, with 90 per cent of young people in the program engaged in educational or employment pathways and 100 per cent increased their participation in social or recreational activities.
